2026-2027 School Year Tuition and Fees

- Tuition \$ 11,400 per student
- Student Life Fee \$ 400 per student
- Graduation Fee \$ 300 per student **(SENIORS ONLY)**

Fees

- ***Student Life Fee: All students will be assessed a \$400 Student Life Fee.** This fee covers student-issued Chromebook, Campus ministry activities including class retreats, athletics, and a host of other student programming. The Student Life Fee does not include costs for: parking, schedule changes, yearbook, graduation, AP Exams, Pre-ACT testing, individual field trips and/or course related fees or any additional specific extracurricular/athletic fees.
- ****Graduation Fee: All Seniors will be assessed a \$300 Graduation Fee** to cover Senior Appreciation and Commencement activities, Senior Yearbook, and cap & gown.
- **Student Life Fee and Graduation Fee are not covered by any scholarship money** including EdChoice, Jon Peterson Scholarship, or Merit Scholarship. Every student attending Cardinal Mooney must pay a minimum of the Student Life Fee.

Families have the following options to pay tuition and fee(s):

- Payment in full by cash, check, or credit card/Apple Pay via invoice link
- Enrollment in FACTS Tuition Management program is **REQUIRED** by all families not paying their tuition in full. There is a \$35 cost per family for enrolling in FACTS.
- Diocese of Youngstown Federal Credit Union Tuition Loan

EdChoice

The State of Ohio offers two EdChoice programs.

1. The **Educational Choice (EdChoice) Traditional Scholarship Program** offers students in grades K – 12 the opportunity to attend a private school for a reduced cost. Students from designated public school districts qualify for these scholarships.
2. The **EdChoice Expansion Program** is an income-based program. It provides K-12 students attending a private school, state-scholarship money to go towards tuition. **All Ohio families are eligible and will receive a minimum of \$840.** This program is only open to students who do not qualify for the Educational Choice Traditional Scholarship.

Jon Peterson

The Jon Peterson Special Needs (JPSN) Scholarship Program provides scholarships to students who have an Individualized Education Plan (IEP). Students with Jon Peterson and blocked into Guided Intervention are assessed an additional \$5,500 (\$46/Hourly Rate) fee for Intervention Services. Cardinal Mooney applies all JPSN scholarship money up to the balance of tuition and intervention services. The family is responsible for any remaining balance after JPSN money is applied. Families who qualify as low income are eligible for tuition assistance for the remaining balance.

Financial Aid and Scholarship

Please note that Cardinal Mooney and the Diocese of Youngstown offer financial aid and scholarship(s). These scholarships are listed on the Cardinalmooney.com website. Families can find the Cardinal Mooney Common Scholarship Application on our website under the Financial Aid tab and in the main office. Completed applications are due on April 15. Families are encouraged to apply for EdChoice first.

Families who would like to apply for Diocesan aid, must apply through FACTS Grants and Aid by March 15. Once FACTS Grants and Aid is complete, they are also registered for the Diocese of Youngstown Foundation Catholic School Tuition Assistance Fund. This scholarship is given annually by the Diocese to the neediest of families.

Statement of Understanding

Our family understands that our relationship with Cardinal Mooney High School is contractual and contingent upon our adherence to the philosophy, policies, and procedures of the School. I am aware that the Family/ Parent Handbook is posted on the school's website or I have received a copy of the School's Family/Parent Handbook that contains the School's philosophy, policies, and procedures and I acknowledge and agree that adherence to the School's philosophy, policies, and procedures is an express condition for admission and continued enrollment by the student. I understand that this agreement is for the 2026-2027 school year, and continued attendance at Cardinal Mooney High School will be determined annually.

It is understood that a parent's obligation to pay the charges for tuition, student fee, and other school fees for the full academic year is unconditional and that no portion of such charges so paid or outstanding will be refunded or canceled notwithstanding the subsequent absence, withdrawal, or dismissal from Cardinal Mooney High School of the student. It is understood that enrollment may be canceled in writing, without penalty prior to August 1. If enrollment is canceled after August 1, parents or guardians financially responsible for the student are obligated to pay a portion of the tuition prorated for the school year.

ADDITIONAL TERMS AND CONDITIONS

1. I agree that all payments owed under this Agreement will be paid by the due date corresponding to the payment method(s) selected below. I understand and agree that, regardless of what payment option is selected, I am personally responsible for the payments and for ensuring that the tuition and fees are paid in full. Should I be late in making any payment, I understand that the following process will be followed:
 - a. I, and the other parents/guardians (if they are not me), will be notified of any payment not received.
 - b. A \$50 late fee will be assessed on FACTS Tuition.
 - c. I will be given five calendar days to bring the account to current status.
 - d. If, within five calendar days, the account is not brought to current status, I may be required to meet with the school administration to discuss my student's enrollment status. The school may immediately take any action available and consistent with applicable law in order to collect unpaid tuition owed by me/us including, but not limited to, limiting access to field trips and extra-curricular activities, withholding academic transcripts, referral to a collection agency, and/or the institution of a civil lawsuit to recover the unpaid balance.
2. Any family with an unpaid Tuition and/or Fees balance for the current School Year will not be allowed to register for the following School Year. School records, diplomas, or transcripts may not be released until the current year's Tuition and fees are paid unless special arrangements have been made in writing and signed by the School principal or School president.
3. Prepaid Tuition will only be refunded in full if the school receives written notice of cancellation before the first day that classes for the school year are scheduled to start. Fees are non-refundable.
4. Once the School year begins, Tuition refunds are made quarterly. Should a Student attend School for any portion of a quarter (one day or more), the full tuition amount for that quarter is owed, and no portion of that quarter's tuition will be refunded except at the discretion of the President or Principal.
5. The Student(s) and Student's parents/guardians agree that they and their child(ren)/ward(s) will abide by the policies and guidelines as stated in the School Handbook.
6. Returned checks: If two checks are returned for insufficient funds, the school will no longer accept personal checks, and you will be required to pay in cash, with a certified check from a local bank, or through FACTS or another electronic payment provider at the school's discretion.

By signing below, I agree that I have read and understand all of the terms and conditions contained in this agreement (including the mandatory **\$400 life fee** for all students not covered by scholarship), and I agree to be personally and legally bound by those terms and conditions.
